FREQUENTLY ASKED QUESTIONS/ TERMS AND CONDITIONS OF
PURCHASE**

Q1. WHERE IS PAVILION PALACE?

A PAVILION PALACE is an undeveloped parcel of land in Ifa Ikot, Abia Ntuen Etoi Clan, Uyo Local Government, Akwa Ibom State.

Q2. WHO ARE THE OWNERS/DEVELOPERS OF PAVILION PALACE?

A PWAN RUBY, a Leading Real Estate Company with offices in Enugu State, Owerri Imo State , Awka Anambra State, Uyo, Akwa-Ibom State, Port Harcourt, Rivers State, Asaba, Delta State & Lekki, Lagos State.

Q3. WHAT TYPE OF TITLE DOES PAVILION PALACE HAVE ON THE LAND?

A C of D (Certificate of Deposit)

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government interests or adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE?

A Outright payment of N7,500,000 only per 464sqm

B 6 Months Installment Payment can be arranged.

N.B: Non-Payment of the monthly installments as at when due shall be treated as a fundamental breach of the contract which shall result in termination or revocation of the contract/ OR attract default charge of 10% of the month payment.

Q6. WHAT IS THE SIZE OF THE PLOT?

A 464 SQM

Q7. IS THE ROAD TO THE ESTATE MOTORABLE ?

A Yes. The road to the estate is motorable and is maintained by PWAN.

Q8. WHAT OTHER PAYMENTS DO I MAKE APART FROM THE PAYMENT FOR THE LAND ?

A Development Fee: N2,000,000 only per plot (Subject to review upwards) Development fee Covers the following: Gate House, Perimeter Fencing, Landscaping, Road sand-filling and creation.

B Infrastructure Fee: (To be determined later) covers the following (1) Drainage construction (2) Electrification (3) Creation of good road network (4) Special amenities.

Q9. WHEN DO I MAKE THE OTHER PAYMENTS?

A (i) Deed of Assignment, Provisional Survey Fee and Corner Plot Demarcation payment can be made immediately. (ii) Development Fee can be made after physical allocation of plot.

Q10. WHAT DO I GET AFTER THE INITIAL PAYMENT DEPOSIT?

B A Charge of 10% of the land consideration (Covering Transfer Documentation Fee) shall be paid to the company by the buyer.

Q15. CAN I PAY CASH TO YOUR AGENT?

A We strongly advise that cash payments should ONLY be made to PWAN Ruby Properties and Development Limited at its designated Banks. Otherwise, cheque(s) should be issued in favor of PWAN Ruby Properties and Development Limited. We shall not accept any responsibility for any liability that may arise as a result of a deviation from the above instruction.

Q16. WHAT HAPPENS IF I CANNOT CONTINUE WITH MY PAYMENT? CAN I REQUEST FOR A REFUND?

A Yes, you can apply for refund only if you have NOT been allocated your plot(s). In the event of a Refund, you are required to give the Company Ninety (90) days' notice to process your refund request and a further Sixty (60) days if the process isn't completed after the first 90 days. The refund shall be processed and paid less 40% (Administrative Fee and Others).
